#### LORD LIEUTENANTS

In Ayrshire, as in other counties, no Lord Lieutenants were appointed after the beginning of George I's reign (1714) till 1794.

- Archibald, 11th Earl of Eglinton, appointed 17 March 1794, died 30 Oct. 1796.
- Hugh, 12th Earl of Eglinton, appointed 23 Nov. 1796, died 15 Dec. 1819.

#### SHERIFFS

- Mr. William Duff of Crombie, advocate, appointed 18 Mar. 1748, and again 6 Mar. 1761; died 8 Jan. 1781.
- William Wallace of Cairnhill, advocate, appointed 9 June 1775; died 28 Dec. 1786.
- William Craig, advocate, afterwards Lord Craig, appointed 26 Mar. 1787; became a Lord of Session 21 Dec. 1792; died 8 July 1813.

BARGANY—created Lord Bargany, 1641; title extinct, 1736. Seat: Bargany.

CARRICK—earldom created 1225/30, title later merged in the Crown; by Act of 22 Nov. 1469 an appanage of eldest son of the Monarch.

CASSILLIS—er. Lord Kennedy, 1457/8; Earl of Cassillis, 1509. Seats: Cassillis, later Culzean.

John Kennedy, born Apr. 1700, succ. grandfather as 8th Earl, 22 Feb. 1704, died 7 Mar. 1759.

Thomas Kennedy, kinsman, by decision of Court of Session 29 Feb. 1760 and House of Lords 27 Jan. 1762, succ. as 9th Earl, died 30 Nov. 1775.

- 1775 David Kennedy, succ. brother as 10th Earl, died 18 Dec. 1792.
- 1792 Archibald Kennedy, kinsman, succ. as 11th Earl, died 30 Dec. 1794.
- 1794 Archibald Kennedy, born Feb. 1770, succ. father as 12th Earl, cr. Baron Ailsa of Ailsa 12 Nov. 1806, cr. Marquess of Ailsa 10 Feb. 1831, died 8 Sept. 1846.

CATHCART—cr. Lord Cathcart, 1452. Seats: Sundrum and Auchincruive.

1740 Charles Schaw, born 21 Mar. 1721, succ. as 9th Lord Catheart 20 Dec. 1740, died 14 Aug. 1776, with heirs. Sundrum and Auchineruive both sold c.1750.

COLVILL—er. Lord Colvill of Ochiltree, 1651; title extinct, 1728, but claimed by successors till 1847.

DUMFRIES—cr. Lord Crichton of Sanquhar, 1487/8; Viscount of Air, 1622; Earl of Dumfries, Viscount of Air, Lord Crichton of Sanquhar and Cumnock, 1633. Seat: Dumfries House, Cumnock.

1742 William Crichton-Dalrymple, succ. mother as 4th Earl of Dumfries, 6 Mar. 1742, succ. younger brother as 4th Earl of Stair, 1760, died Dumfries House, 27 July 1768.

1768 Patrick Macdowall, born 15 Oct. 1726, succ. uncle as 5th Earl of Dumfries, died Edinburgh 7 Apr. 1803.

DUNDONALD—cr. Lord Cochrane of Dundonald, 1647; Earl of Dundonald, Lord Cochrane of Paisley and Ochiltree, 1669. Seat: Auchans.

1737 William Cochrane, born Paisley 1729, succ. father as 7th Earl 27 May 1737, killed at siege of Louisburg 9 July 1758, unmarried.

1758 Thomas Cochrane, succ. cousin as 8th Earl, died at Lamancha, Peeblesshire, 27 June 1778.

1778 Archibald Cochrane, born 1 Jan. 1748, succ. father as 9th Earl, died Paris 1 July 1831.

EGLINTON—cr. Lord Montgomerie, c.1445; Earl of Eglintoun, 1506/7. Seat: Eglinton.

1729 Alexander Montgomerie, born 10 Feb. 1723, succ. 18 Feb. 1729 as 10th Earl, murdered 24 Oct. 1769.

1769 Archibald Montgomerie, born 18 May 1726, succ. brother as 11th Earl, died at Eglinton 30 Oct. 1796.

1796 Hugh Montgomerie, born 29 Nov. 1739, succ. kinsman as 12th Earl, cr. Baron Ardrossan of Ardrossan 15 Feb. 1806, died 15 Dec. 1819.

GARNOCK—er. Viscount (Mount-Crawford, changed to) Garnock and Lord Kilbirnie, Kingsburne, and Drumry, 1703. Seat: Kilbirnie House.

1737 George Crawford, born 14 Mar. 1729 at Kilbirnie, succ. father as 4th Viscount in 1737, succ. as 21st Earl of Crawford and 5th Earl of Lindsay, 15 Jan. 1757, died 11 Aug. 1781.

1781 George Crawford, born Bourtreehill, 31 Jan. 1758, succ. father as 5th Viscount, etc., died unmarried at mother's home, Rozelle, Ayr, 30 Jan. 1808.

GLASGOW—cr. Lord Boyle of Kelburn, Stewartoun, Cumbrae, Finnick, Largs, and Dalry, 1699; Earl of Glasgow, Viscount Kelburn, and Lord Boyle of Stewartoun, Cumbraes, Fenwick, Largs, and Dalry, 1703. Seat: Kelburn.

John Boyle, born Edinburgh 4 Nov. 1714, succ. father as 3rd Earl, 22 May 1740, died Kelburn 7 May 1775.

1775 George Boyle, born 18 Sept. 1765, succ. father as 4th Earl, cr. Baron Ross of Hawkhead 11 Aug. 1815, died 3 July 1843.

GLENCAIRN—cr. Lord Kilmaurs, 1463; Earl of Glencairn, 1488, 1503. Seats: sometime Kilmaurs and Kilmarnock House. (The Scots Peerage has been followed in entitling these as 12th, 13th, and 14th Earls, though Paterson and others refer to them as 13th, 14th, and 15th.)

William Cuninghame, succ. father as 12th Earl, 14 Mar. 1734, died Finlaystoun 9 Sept. 1775.

James Cuninghame, born Kilmalcolm 1 June 1749, succ. father as 13th Earl, died Falmouth 30 Jan. 1791.

John Cuninghame, born Finlaystoun 17 May 1750, succ. brother as 14th Earl, died Coates 24 Sept. 1796 without issue. Earldom dormant, despite unsuccessful claim by Sir Adam Fergusson, Bart., House of Lords decision 14 July 1797.

KILMARNOCK—er. Lord Boyd of Kilmarnock, 1459, 1482, 1564; Earl of Kilmarnock, 1661. Seat: Dean Castle.

William Boyd, born 12 May 1705, succ. father as 4th Earl in 1717 (Sept. or 22 Nov.), executed for high treason, Tower Hill, 18 Aug. 1747. Earldom extinguished by act of attainder.

James, Lord Boyd, born Falkirk 20 Apr. 1726, recovered estates 28 Mar. 1751 (and sold them soon after), succ. as 15th Earl of Errol 19 Aug. 1758, died Callendar House 3 July 1778.

LOUDOUN—cr. Lord Campbell of Loudoun, 1601; Earl of Loudoun and Baron Tarrinzean and Mauchline, 1633.

Seat: Loudoun.

John Campbell, born 5 May 1705, succ. father as 4th Earl 20 Nov. 1731, died Loudoun Castle 27 Apr. 1782, unmarried.

James Mure Campbell, born Edinburgh 11 Feb. 1726, succ. cousin as 5th Earl, died Loudoun Castle 28 Apr. 1786.

1786 Flora Mure Campbell, born Aug. 1780, succ. father as Countess of Loudoun, in care of Earl and Countess of Dumfries till 1803, married 12 July 1804 the 2nd Earl of Moira, cr. Marquess of Hastings, Earl of Rawdon, and Viscount

Loudoun, 7 Dec. 1816, who died 28 Nov. 1826; the Marchioness died Kelburn Castle 8 Jan. 1840.

MARCHMONT—cr. 1697. Seat: Cessnock, 1704-c.1770.

1724 Alexander Hume, born 1675, married 29 July 1697 Margaret Campbell of Cessnock, succ. father as 2nd Earl of Marchmont 1 Aug. 1724, died 27 Feb. 1740.

1740 Hugh Hume Campbell, born 15 Feb. 1708, succ. father as 3rd Earl, sold Cessnock, died Hemel Hempstead, 10 Jan.

1794.

STAIR—cr. Baronet, 1664; Viscount of Stair, Lord Glenluce and Stranraer, 1690; Earl of Stair, Viscount Dalrymple, Lord Newliston, Glenluce, and Stranraer, 1703. Seat: Stair.

1747 James Dalrymple, by decision House of Lords (4 May 1748) succ. kinsman as 3rd Earl 9 May 1747, died at Castle

McDouall, Wigtownshire 13 Nov. 1760.

William Crichton-Dalrymple, born 1699, who succ. as 4th Earl of Dumfries 1742, succ. younger brother as 4th Earl of Stair, died Dumfries House, Cumnock 27 July 1768.

1768 John Dalrymple, cousin, succ. as 5th Earl, died Culhorn,

Wigtownshire, 13 Oct. 1789.

#### MEMBERS OF PARLIAMENT

#### House of Lords

After 1707 the peers of Scotland elected for each parliamentary term 16 Representative Peers to sit in the House of Lords. The following Ayrshire peers were among those so chosen. See W. Robertson, *Proceedings relating to the Peerage of Scotland*, 1707-1788 (1790); and *Scots Peerage*.

CASSILLIS—9th Earl, from 1774 till death in 1775 in that same term. 10th Earl, who had previously sat in the Commons, filled casual vacancy 1776, re-elected till death in 1792.

CATHCART—9th Lord Cathcart, filled casual vacancy 1752, re-elected till death 1776. (His Ayrshire connections ceased with sale of estates c.1750).

DUMFRIES-5th Earl, from 1790 till death 1803.

EGLINTON—10th Earl, from 1761 till death 1769. 11th Earl, who had previously sat in Commons, filled casual vacancy 1776, re-elected till death 1796.

GLASGOW-4th Earl, 1790 till 1815.

GLENCAIRN—13th Earl, one term 1780 till 1784.

LOUDOUN-4th Earl, 1734 till death 1782.

MARCHMONT—3rd Earl, filled casual vacancy 1750, re-elected till death 1794. (His Ayrshire connections ceased with sale of estates c.1770).

STAIR—5th Earl, filled casual vacancy 1771, till end of term 1774.

#### House of Commons

After 1707 Scotland sent to Westminster 30 members to represent the shires, elected by freeholders (v.infra), and 15 to represent the royal burghs—each town council choosing a commissioner who with the others from the district met to elect the member. The designation of the members in the list is as given in the Official Returns of Members of Parliament. Compiled by Sir James Fergusson, Bart.

#### FREEHOLDERS

Annually at Michaelmas a meeting was held at the head burgh of each shire to draw up the Roll of Freeholders, who as occasion arose met to elect the shire's member of parliament. Those enrolling were required to be adult commoners, conforming protestants, and possessed of forty shilling land of old extent, or other land of four hundred pounds Scots valued rent. After 1707 and particularly in the later part of the century, the roll was swollen by 'nominal and fictitious' voters as the owners of large estates allocated suitable portions to political friends. After the religious disturbances of the 17th century, the presbyterian constitution of the Kirk had been recognised in 1690 and ratified in 1707. In each parish the congregation was ruled by a Kirk Session comprising the Minister and Elders appointed for life. For each group of parishes there was a Presbytery, composed of all the Ministers and some of the Elders which supervised the ecclesiastical life of its area and sent representatives to the provincial Synod and the annual national meeting of the General Assembly.

During this period there was division in the Established Kirk between the 'Moderates' who, under the influence of 18th century philosophical ideas, preached moderation, common-sense, and emphasised the moral virtues, and who supported the system of patronage; and the 'Evangelicals' or 'High Flyers' who stood firm for Reformation and Covenanting traditions, insisting on the importance of original sin, faith, and grace. In Ayrshire these two groups were sometimes referred to as 'New Lights' and 'Old Lights.'

Doctrinal divisions and disputes regarding the appointment of ministers (patronage had been restored in 1712) resulted in a number of local tumults and the secessions noted below.

For a detailed study of ecclesiastical life and problems see A. Edgar, Old Church Life in Scotland, 2 vols., 1885, 1886, which deals especially with Mauchline.

#### General Associate Synod (Anti-burghers)

The original secession from the Church of Scotland in 1733 was followed by a schism among the seceders in 1747 regarding the taking of the burgess oath. The following lists give details from the time a meeting house was established and a regular congregational life instituted, but in many cases there were groups receiving a supply of sermon for years before that was arranged. For studies of some of the secession ministers, see Mitchell, Memories of Ayrshire.

KILMAURS—the first secession congregation in the county.

1740 David Smyton, ord. 13 Nov. 1740, church built 1742; in 1747 he at first sided with Burghers but confessed error and re-instated; in 1782 he and majority of congregation insisted on lifting of bread before blessing despite prohibition of the Synod. The 'Lifters' retained congregational properties by Court of Session decision 1785.

William Robertson, ord. as assistant and successor, late 1788; Smyton died 16 March 1789; Robertson 'left'

later in that year.

The Lifters continued in DALRY.

John Gemmell, ord. Dalry 'Lifters' congregation c.1789, 1822 left for America and congregation broke up.

The Anti-Lifters of Kilmaurs built new meeting house 1788. George Paxton ordained to combined charge of Kilmaurs and Stewarton 12 Aug. 1789, became Professor of Theology, Edinburgh, 1808, D.D. St. Andrews 1834; died 1837.

AUCHINLECK—Covenanting praying society, meeting at Wallacetoun farm, joined Associate Presbytery 1738, built church at Rigg, 1756.

1763 Robert Smith, ord. 30 Nov. 1763, resigned due to age and infirmity 31 Jan. 1809, died at son's manse in Kilwinning, 21 June 1817, aged 84.

KILWINNING—church built 1758.

1763 William Jameson, ord. 6 April 1763, died 23 Nov. 1792. 1796 Robert Smith, son of Robert Smith of Auchinleck (q.v.), ord. 15 June 1796, died 22 June 1835.

#### SCHOOLS

For a detailed study of education in 18th century Ayrshire see William Boyd, Ayrshire Education Through Seven Centuries, 1959. While early in the century there were parishes without

any schools, by the time of the Stat. Acct. there were schools in every parish, provided by the heritors in association with the kirk session. In Ayr, Irvine, and Kilmarnock the schools were the responsibility of the town councils, and offered as the century advanced a greater variety of subjects. In 1745 the Ayr school was reorganised and became 'in effect, though not in name, the first academy in Scotland'; in 1798 Ayr Academy was established, to be followed later by Kilmarnock (1807) and Irvine (1814). Where facilities were inadequate or insufficient, adventure schools sprang up under private auspices, like John Murdoch's school at Alloway. Sunday schools were established at Ochiltree (by the Dowager Countess of Glencairn) and Galston (by Miss Scott of Cessnock) in the 1780s.

Lists of local schoolmasters are given in various parish and town histories, but there is no complete record.

The Grand Lodge of Scotland was formed in 1736; Mother Lodge Kilwinning (est. 1599) took part in the institution, but resumed its independence in 1743 and continued to charter other lodges, including many furth of Ayrshire.

#### AGRICULTURAL SOCIETIES

Society for improving of agriculture and manufactures in the Shire of Ayr. Established before April, 1748; founded by Alexander, 10th Earl of Eglinton, who was its president for many years; its clerk was William Paterson, writer Kilmarnock. It offered premiums to farmers who carried out improvements. (Scots Magazine, x, 187-190; Stat Acct., xi, 175; Aiton, 678; Handley, Scottish Farming in the 18th Century, 167-9). There is no record of how long it continued in existence.

- Farmers' Society of Kilmarnock. Established c.1786 (according to Aiton, 678), 1792 (McKay, Kilmarnock), or 1793 (McCarter, Ayrshire, 1832). Met first Friday of every month to dine and discuss selected farming topics; organised ploughing matches and cattle shows, 'attended by vast crowds.'
- Carrick Farmers' Society. Established 1797. Rev. John Ramsay, M.A., minister of Kirkmichael, founder and first president. Met four times annually in Maybole; organised ploughing matches, cattle shows, provided premiums for destroying rooks, etc., supplied gratuities to reapers from Highlands. (Aiton, 680; McCarter, op.cit.; Fasti, Kirkmichael.)
- Tarbolton—a Farmer Club (for agricultural improvement) and a Farmer Society (friendly society)—Stat. Acct., xix, 454. There were, by the end of the century probably, certainly by a decade later, numerous other local societies.

#### BANKS

1763 John McAdam & Co., Ayr. Among the founders was James McAdam, father of the roadmaker. This bank was taken over 1 Jan. 1771, by the next mentioned.

Douglas, Heron & Co., Ayr, with branches in Edinburgh and Dumfries. Established 6 Nov. 1769. List of shareholders given in James Paterson, Contemporaries of Burns, 1840, appendix. On Black Monday, 12 June 1772, it collapsed, resulting in the impoverishment of many families in the west of Scotland, and the sale of many Ayrshire estates. The company was liquidated in 1774. See Henry Hamilton, 'The Failure of the Ayr Bank', Economic History Review, Vol. 8, No. 3.

James Hunter & Co., Ayr, with offices in Maybole and Irvine. James Hunter had been cashier in the preceding bank.

1775 Bank of Scotland opened offices in Ayr and Kilmarnock. Sometime after 1783 the Paisley Bank opened a branch in Irvine.

Measures and standards varied in different parts of Scotland, and fluctuated over a period of time: the Scots Parliament had never been able to regularise the position. The Act of Union, Articles 16 and 17, stipulated that English measures should become general, but local measures continued in use throughout the 18th century. Imperial standards were not introduced till 1836. It is often difficult to decide which measure is being referred to, or to decide its modern equivalent.

of 0.97 and 1.33 firlots of Linlithgow measure. There was also an Old Ayrshire Bear measure with one firlot the equivalent of 1.82 imperial bushels. But it was extremely difficult to standardise such measures, complicated further because measures were sometimes heaped, sometimes straiked. There were considerable variations even within Ayrshire. And for comparatively new commodities like potatoes and lime there were no commonly-accepted standards at all. The general tendency was for meal to be sold by weight; as far as grain was concerned, by the early 19th century the Winchester bushel (equivalent of 0.97 imperial bushels) was commonly used. For prices of wheat, bear, oats, meal over a period of years, see Aiton, 170-2.

## A NOTE ON DATES

At the beginning of our period the calendar was reformed. The nature of the alteration was noted in the Session Records of the Parish of Dailly as follows—quoted in *Carrick*, p. 172:

### " Aug. 2, 1752.

"By act of Parliament, the Julian form of the year, or old stile, ends with the second day of September, one thousand seven hundred & fifty-two, and the Gregorian, or new stile succeeds, whereby eleven days are taken out of the month of September forsaid, current year. All following dates are accordingly made after the new stile."
